1. **PRE-REGISTRATION ONLY:** There will be ***no registration at the gate*** on any scheduled Market day. Exhibitor may register for all or any of the three 2012 Art and Craft Markets no later than 7 working days before the event. Specific space requests will be honored on a first come first served basis with paid application. A confirmation with your space number will be mailed to you the week before the scheduled event.

2. **SPACE SIZE IS 10'x10'** Price is for space only. You must provide your own tables, chairs or canopy

3. **SET-UP: 8:00 AM** (Gates will not open earlier) Crafters must be at their assigned space by 9:15am

4. **OPEN TO THE PUBLIC:** 10:00 AM – 4:00 PM. Crafters cannot break down their displays prior to 4:00pm

5. **REGULATIONS:**
 - a. Crafter's items will be juried by photographs upon registration (new vendors only).
 - b. First time crafters must provide three photos: one of saleable items, one of items being made, & one of display.
 - c. Items must be hand crafted, painted or photographed by the exhibitor.
 - d. Crafter must be in attendance on the date of the market.
 - e. Spaces may not be sublet. Commercial products cannot be sold. Dried/silk flowers must be in arrangements.
 - f. Pre-purchased, pre-assembled or raw kits cannot be displayed or sold.
 - g. Crafter must be able to produce licensing agreement for any trademarked items on display.
 - h. Removal of inappropriate items will be requested. Failure to comply may result in expulsion.

6. **NO REFUNDS.** Once accepted into any Allaire Village Inc. Craft Market, your registration fee cannot be returned.

If the weather is questionable, call 732-919-3500 after 6:30am for a message on rain date.

If you are selling on more than a "casual" basis, the State Div. of Taxation requires you to have a Sales Tax Certificate.
